COURSE DESCRIPTION

School avoidant behavior is defined as a refusal to attend school or difficulty engaging in school for the entire day. Since the pandemic, school avoidance has increased in all age groups, and has negatively impacted kids and teens academically, socially, and emotionally. Presentations range from young children with separation anxiety to more severe instances where a student refuses to attend school entirely. The more chronic the condition (the longer the refusal behavior continues), the more challenging it becomes to return the child to a regular school schedule.

Dr. Aimee Kotrba will provide an overview of the causes, signs and subtypes of school refusal and academic avoidance. Participants will understand what tools they need to assess, plan, and develop strategies for helping children return to school and engage in schoolwork successfully. Through a combination of an expert-led presentation, interactive activities, and discussion tasks, participants will gain insight into the most effective interventions and explore best practice when dealing with school refusal/avoidance. Participants will gain the tools and knowledge necessary to help students achieve success on their return to school.

Learner Objectives: Upon completion of this course, participants will be able to:

- Identify the underlying causes of school refusal and academic avoidance
- Explain strategies for supporting children in overcoming obstacles to returning to school
- Discuss appropriate interventions to help children reduce academic avoidance and engage in classroom activities and homework

She loves clinical work but has also taught graduate-level psychology at Michigan State University and has worked as a neurodevelopmental consultant/evaluator at St. Joseph Hospital for over 10 years. She is a nationally-known expert and speaker on the identification and treatment of Selective Mutism, a childhood anxiety disorder, and loves working with families to promote "brave talking".

Dr. Kotrba has authored **Selective Mutism: An** Assessment and Intervention Guide for Therapists, Educators, and Parents and Overcoming Selective Mutism: A Field Guide for Parents She created and co-directs Confident Kids Camp, a camp for children and teens with Selective Mutism that runs annually in Brighton Michigan (with offshoot camps in the metro DC area and Toronto, Canada). She also provides education to parents, school personnel, and professionals about Selective Mutism, offering informative and engaging webinars including Unlocking the Mystery of Selective Mutism.
